# Bad Boy Mowers "Willow Oak Father's Day Trip" Sweepstakes Official Rules

# NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

**1. Eligibility:** Willow Oak Lodge Father's Day Trip (the "Sweepstakes") is open only to legal residents of the 48 continental states of the United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. 4. How to Enter: (1) During the Promotion Period, visit https://badboycountry.com/willowoakfathersdaytrip and complete and submit the registration form including a valid email address. You automatically will receive one (1) entry into the Sweepstakes. Limit: You may enter one (1) time during the Promotion Period.
