

Bad Boy Mowers “2025 Mother’s Day” Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Bad Boy Mowers “2025 Mother’s Day” Sweepstakes (the “Sweepstakes”) is open only to legal residents of the 48 continental states of the United States (including the District of Columbia) who are at least eighteen (18) years old at the time of entry. Employees of Bad Boy Mowers (“Sponsor”) and its parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible as entrants or nominees. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes entrant’s full and unconditional agreement of the entrant and nominee to these rules and Sponsor’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. Entrant and Nominee: The “Entrant” is the person who completes the entry form and nominates a person to receive the prize. The “Nominee” is the person nominated by the Entrant on the entry form to receive the prize. An Entrant may only submit one entry for one Nominee. A Nominee may be entered by more than one Entrant, provided the entry rules set forth in paragraph 4 are strictly followed.

3. Timing: The Sweepstakes begins on April 10, 2025, at 12:00 a.m. Central Time (“CT”) and ends on May 1, 2025, at 11:59 p.m. CT (the “Promotion Period”). Sponsor shall determine any timekeeping issues it is sole and absolute discretion.

4. How to Enter: (1) Online: During the Promotion Period, visit <https://badboycountry.com/mothers-day-giveaway> and complete and submit the entry form including a valid email address. You will receive one entry into the Sweepstakes. You may only enter one time during the Promotion Period. **(2) Mail:** To enter via mail, hand print your complete name, address, city, state, zip code, telephone number, and email address, and the Nominee’s complete name, address, city, state, zip code, telephone number, email address, and statement of why the Nominee deserves this opportunity, on a 3” x 5” card/paper, and mail in a first-class stamped envelope to: “2025 Mother’s Day” Sweepstakes, 102 Industrial Dr., Batesville, AR 72501, to be postmarked by April 30, 2025 and received by May 1, 2025, or will be forfeited. You may only enter one time during the Promotion Period, with a limit of one entry per outer envelope. Multiple entrants are not permitted to share the same home address. Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different home addresses, identities, registrations, and/or logins, or any other methods, will void that Entrant’s entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. The winning Entrant may be required to show proof of being the authorized account holder.

5. Prize Drawing: The winning entry will be randomly drawn from among all eligible entries. The Entrant and the winning Nominee shall be notified by Sponsor via email and/or phone call within seven days of the drawing. The prize shall belong to the winning Nominee; the Entrant shall have no right, or claim, to the prize whatsoever. All decisions of the Sponsor are final. In order for the winning Nominee to receive the sweepstakes prize the entry details for the Entrant and Nominee (i.e. name, email address, mailing address) must be confirmed by the Sponsor. Failure of the Entrant and winning Nominee to confirm the information on the entry form with Sponsor within seven days of the email being sent to the winning Nominee’s email address by Sponsor will void the selection and another Nominee shall be drawn from among all eligible entries. The landscaping, which is the subject of the prize, must be completed within one year of the drawing.

6. Prize: Sponsor shall pay a landscaper up to \$5,000 for backyard, front yard, or garden area makeover (“Prize”). The landscaper shall be selected by Sponsor with input from an area Bad Boy Mower dealership. The winning Nominee will have the final say in the makeover, but payment shall be made to the landscaper selected by Sponsor to perform the work. The winning Nominee shall have no right, or claim, to the \$5,000, other than for the funds to be paid to the landscaper as set forth herein. The retail value of the Prize is \$5,000. The Prize is non-transferable, and no substitution will be made except as provided herein at

Sponsor's sole and absolute discretion. Sponsor reserves the right to substitute the Prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winner is responsible for all taxes and fees associated with the Prize. Odds of winning the Prize depend on the number of eligible entries received during the Promotion Period.

7. Release: By receipt of the Prize, the Entrant and winning Nominee agree to release and hold harmless Sponsor and its respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and dealers, and the landscaper selected by Sponsor, and each of their respective parent companies and each such company's officers, directors, employees, and agents (collectively the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of the Prize.

8. General Conditions: Sponsor reserves the right to cancel, suspend, and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole and absolute discretion. In such event, Sponsor, in its sole and absolute discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for the Prize offered herein. Sponsor reserves the right, in its sole and absolute discretion, to disqualify any individual who tampers with the entry process or the operation of the Sweepstakes or who violates these rules or disrupts the Sweepstakes. Any attempt by a person to deliberately undermine the operation of the Sweepstakes may violate criminal and/or civil law and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these rules shall not constitute a waiver of that provision.

9. Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the Sweepstakes, (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software, (3) unauthorized human intervention in any part of the entry process or the Sweepstakes, (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries, (5) late, lost, undeliverable, damaged, or stolen mail, or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the Entrant's or Nominee's participation in the Sweepstakes or receipt or use or misuse of the Prize. If for any reason an Entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, the Entrant's sole remedy is another entry in the Sweepstakes, if it is possible. No more than the stated number of prizes (one) will be awarded. In the event that production, technical, seeding, programming, or any other reasons cause more than the stated number of prizes (one) set forth in these rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of prizes (one) by a random drawing among all legitimate, un-awarded, eligible prize claims.

10. Disputes: Except where prohibited, the Entrant and Nominee agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Arkansas or the appropriate Arkansas State Court located in Independence County, Arkansas, (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees, and (3) under no circumstances will the Entrant or Nominee be permitted to obtain awards for, and the Entrant and Nominee hereby waive all rights to claim, indirect, punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation, and enforceability of these rules, or the rights and obligations of the Entrant, Nominee, and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Arkansas without giving effect to any choice of law or conflict of law rules (whether of the State of Arkansas or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Arkansas.
